1. Question: "Plotter Printer Provision/Service – Section A, states "Supports uncoated media compatible with eco-solvent inks. Does this mean the printer must print on similar types of media that compatible with eco-solvent or that the unit must use eco-solvent inks to print?"

Answer: It means similar types of media compatible with eco-solvent. It is not referring to the type of inks that must be used.

2. Question: "Same Section, Does the statement that all consumables are included mean all types of paper or only a standard 20lb paper? The cost of paper can vary widely based on the application being printed. If all types of paper are included we would need to safe guard ourselves in case an expensive fabric was ordered."

Answer: All consumables to include, service, ink, parts and labor. Paper is not included..

3. Question: "What type of documents will be printed on the unit? The answer will greatly affect the cost of the response due to ink usage."

- d. Fabric Banners?

Answer: A, B & C.

4. Question: “IX, page 13: Delivery and Installation.”

Answer: A-Yes, B-Standard Elevator Only, C-Yes and D-Yes.
