*City's response to the following submitted question(s):* 

1. Question: "The pricing page specifies "9.5mm Level A" this is not a GDOT mix design designation,

please clarify?"

**Answer:** 9.5mm Level A is hereby change to read 9.5mm Type 2 Hot Asphalt. (See Attached

Revised Pricing Page)

2. Question: "Insufficient information is needed to price "Concrete Patching."

**Answer:** Concrete Patching is for Square Yard of 5" thickness.

3. Question: "Hot Asphalt M70 Mix" is not an available product. Please clarify the intent is not

Asphalt Cement MC70?"

**Answer:** M70 mix is hereby change to read MC70 mix. (See Attached Revised Pricing Page)

**4.** *Question:* "Section XI states that materials shall be made available within two (2) hours of order

being placed. This is not practical. Special mixes may only be available once storage space has been ready, crews may need to mobilize to the production plant in the case of an emergency. This should be 24 hours and state the city will place orders no less than

2:00pm the day before."

### Answer:

The City will give a 24-hour notice to receive a special mix. Special mixes such as (ex. 4.5 mm or finer grade mixes.) will be ordered by 2:00 p.m. the day prior to it being ready.

**5.** *Question:* "There are conflicting notes about performance time-frame for mix placed. Please clarify."

Answer: The City typically uses 9.5 mm type 2, which is GDOT standard grade for asphalt mixes;

the City normally places the order for the tonnage needed for that day, 2 hours prior to asphalt plant opening. Also, all emergency repairs that may need material is typically called in 2-4 hours prior, as the City doesn't have any idea as to what situations may arise after hours or during a plant closing, but a 2-4 hour window for the asphalt plant to

make materials in an emergency situation would be ideal.
