WHEREAS, federal regulations require that the Metropolitan Transportation Plans and Transportation Improvement Programs include System Performance Measures (PM3 Targets) for urbanized areas and;

WHEREAS, the Technical Coordinating Committee of the Columbus-Phenix City Transportation Study (C-PCTS) in coordination with the Federal Highway Administration, Federal Transit Administration, and the Georgia Department of Transportation has reviewed the requirement to adopt the System Performance Measures (PM3 – Travel Time) for use in the transportation process;

WHEREAS, the Technical Coordinating Committee at its May 11, 2023, meeting recommended that C-PCTS support the System Performance Measures (PM3 – Travel Time) approved by the Georgia Department of Transportation as follows:

*GDOT, Atlanta Regional Commission and Cartersville-Bartow Metropolitan Planning Organization are required to establish and report single targets for Annual Hours of Peak Hour Excessive Delay (PHED) Per Capita and Percent of Non-Single Occupancy Vehicle (SOV) Travel for Atlanta urbanized area. **NOW, THEREFORE, BE IT RESOLVED** that the C-PCTS Policy Committee concurs with the recommendation of the Technical Coordinating Committee of C-PCTS that C-PCTS agrees to support the System Performance Measures (PM3 – Travel Time) as approved by the Georgia Department of Transportation.
