AN AMENDMENT TO THE 2021-2024 TRANSPORTATION IMPROVEMENT PROGRAM AND THE 2045 METROPOLITAN TRANSPORTATION PLAN TO INCLUDE A PROJECT FOR PHENIX CITY FOR THE MPO TRANSPORTATION ALTERNATIVES PROGRAM (TAP) FUNDS

WHEREAS, the Governors of Georgia and Alabama have designated the Columbus Department of Planning as the Metropolitan Planning Organization (MPO) for the Columbus-Phenix City (C-PCTS) urban area; and

WHEREAS, the City of Phenix City, Alabama has applied for and been approved by the MPO Committees to receive funding from the MPO allocated TAP funds; and

WHEREAS, the TAP funds will be utilized to make improvements along 14th Street between 9th Avenue and 12th Avenue. The improvements will include correcting some ADA deficiencies such as sidewalks, ramps, and cross walks, creation of a bicycle lane, hardscape improvements, and limited landscaping.

WHEREAS, \$846,761.45 (80%) will be funded by ALDOT and the remaining \$254,553.80 (20%) will be required from the City; and

WHEREAS, the total project cost is \$1,101,315.25.

BE IT RESOLVED that the Columbus-Phenix City Transportation Study Policy Committee approves the amendment to the 2021-2024 TIP and the 2045 MTP to include a Transportation Alternatives Program Project for the City of Phenix City, Alabama.
