A RESOLUTION TO AMEND THE GEORGIA SECTION OF THE 2021-2024 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AND THE 2045 METROPOLITAN TRANSPORTATION PLAN (MTP)

WHEREAS the Columbus-Phenix City Transportation Study (C-PCTS) Metropolitan Planning Organization (MPO) is the organization designated by the Governors of Alabama and Georgia as being responsible, together with the State of Alabama and Georgia, for implementing the applicable provisions of 23 USC 134, 135 (as amended by the FAST ACT Sections 1201, 1202 July 2012); 42 USC 7401 et seq.; 49 USC 5303, 5304; 23 CFR Parts 450; 40 CFR Parts 51 and 93; and,

WHEREAS it is necessary to amend the Georgia section of the 2021-2024 Transportation Improvement Program (TIP) and the 2045 MTP to delete the following projects in Columbus; and

- P.I. No. 0017690 Install a Roundabout at 17th Street / Linwood Boulevard / 13th Avenue
- P.I. No. 0017689 Cusseta Road from 10th Avenue to North Lumpkin Road Addition of a turn lane
- P.I. No. 0017687 South Lumpkin Road Streetscapes
- P.I. No. 0017688 Whitesville Road from Whittlesey Road to Williams Road Addition of a turn lane

WHEREAS these projects were on the 2022 TPLOST list, which the citizens voted to approve in May of 2022. These funds are considered local funds; therefore, it is necessary to delete these projects and remove the Z230/Y230 Federal funding.

BE IT RESOLVED that the Columbus-Phenix Transportation Study Policy Committee approve the amendment of the 2021-2024 TIP and the 2045 MTP.






