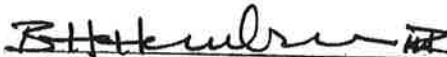
A RESOLUTION TO AMEND THE TRANSIT SECTION OF THE 2021-2024
TRANSPORTATION IMPROVEMENT PROGRAM (TIP).

WHEREAS the Columbus-Phenix City Transportation Study (C-PCTS) Metropolitan Planning Organization (MPO) is the organization designated by the Governors of Alabama and Georgia as being responsible, together with the State of Alabama and Georgia, for implementing the applicable provisions of 23 USC 134, 135 (as amended by the FAST ACT Sections 1201, 1202 July 2012); 42 USC 7401 et seq.; 49 USC 5303, 5304; 23 CFR Parts 450; 40 CFR Parts 51 and 93; and,

WHEREAS it is necessary to amend the Transit section of the 2021-2024 Transportation Improvement Program (TIP) to delete the Preventative Maintenance -- Services from the 5339 FY 23 Capital Purchases in the amount of \$414,190.00 (\$331,352.00 Fed & \$82,838.00 Local).

WHEREAS the total amount of 5339 funds for FY 23 is \$683,400.00 (\$546,720.00 FTA & \$136,680.00 Local).

BE IT RESOLVED that the Columbus-Phenix Transportation Study Policy Committee approve the amendment of the 2021-2024 TIP.
