METROPOLITAN TRANSPORTATION PLAN (MPT)


WHEREAS the Columbus-Phenix City Transportation Study (C-PCTS) Metropolitan Planning Organization (MPO) is the organization designated by the Governors of Alabama and Georgia as being responsible, together with the State of Alabama and Georgia, for implementing the applicable provisions of 23 USC 134, 135 (as amended by the FAST ACT Sections 1201, 1202 July 2012); 42 USC 7401 et seq.; 49 USC 5303, 5304; 23 CFR Parts 450; 40 CFR Parts 51 and 93; and,

WHEREAS the City of Phenix City and Alabama Department of Transportation combined three projects in to one project: and,

WHEREAS it is necessary to amend the Alabama section of the 2021-2024 Transportation Improvement Program (TIP) to change the project description and the funding to the Construction phase of the following Alabama project; and

- P.I. No 100073346 – Resurfacing various streets in Phenix City – Site 1: Knowles Rod from 16th Avenue to 4th Place, Site 2: 4th Place from Knowles Road to Seale Road, Site 3: 43rd Street from Summerville Road to End of 43rd Street. – Construction Cost increased from \$240,000.00 (\$192,000.00 Fed & \$48,000.00 Local) to \$590,000.00 (\$472,000.00 Fed & \$118,000.00 Local).

BE IT RESOLVED that the Columbus-Phenix Transportation Study Policy Committee approve the amendment to the 2045 MTP and 2021-2024 TIP.
