**WHEREAS**, the Governors of Georgia and Alabama have designated the Columbus Department of Planning as the Metropolitan Planning Organization (MPO) for the Columbus-Phenix City (C-PCTS) urban area; as being responsible, together with the State of Georgia and the State of Alabama, for implementing the applicable provisions of amended 23 USC 124 and 135 (SAFETEA-LU Sec. 6001 August 2005); 23 CFR 450 and 500; and

**WHEREAS**, the cited laws and regulation require Metropolitan Planning Organizations to determine the functional classification of roadways in their urban area, and

**WHEREAS**, Russell County, Alabama has recommended that Owens Road from Alabama Highway 165 to McLendon Road, McLendon Road from Owens Road to Owens Road, Owens Road from McLendon Road to Patterson Road, and Patterson Road from Owens Road to Alabama Highway 165 be reclassified from a local to major rural collector, and

**WHEREAS**, the Citizens Advisory Committee, the Technical Coordinating Committee, and Policy Coordinating Committee have reviewed the proposed change to the functional classification system and have recommended that the change be adopted.

**BE IT RESOLVED**, that the Columbus / Phenix City Metropolitan Planning Organization does hereby approve the reclassification of Owens Road from Alabama Highway 165 to McLendon Road, McLendon Road from Owens Road to Owens Road, Owens Road from McLendon Road to Patterson Road, and Patterson Road from Owens Road to Alabama Highway 165 from a local to major rural collector.

WHEREAS, THE County Commission of Russell County, Alabama, is requesting to reclassify sections of various roads included in the Russell County road system and described as follows:



